

3. Receipt of application for issue of tender form by post will be stopped from 1600 hours, four days from date fixed from last date of issue of tenders.
 4. Bidding documents must be delivered in the office of the Managing Director JKPCC Ltd. Jammu through Registered cover, courier service/ speed post on or before 1400 hours on 04-08-2010. If the office happens to be closed on the date of receipt of the bids as specified above, the bids shall be received on the next working date at same time and venue.
 5. Bids will be opened at 1300 hours on 06-08-2010 in the office of the Managing Director JKPCC Ltd. Jammu. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working date at same time and venue.
