## TERMS & CONDITIONS:-

- 1) The tenders should be accompanied with earnest money (as mentioned in NIT) in shape of CDR/ FDR pledged to the Financial Controller, JKPCC Ltd., Srinagar drawn at any scheduled bank. Tenders not accompanied with CDR/ FDR will be liable for rejection. There shall be no liability on Corporation to pay any interest on FDR/ CDR.
- 2) The tender receiving officer shall be at liberty to accept or reject the tenders without assigning any reason.
- 3) Successful tenderer shall have to draw necessary agreement with the Corporation on the prescribed agreement form within seven days from the date of issuance of allotment order.
- 4) In case of any dispute between the firm and the Corporation the matter shall be subject to arbitration and the Managing Director, JKPCC Ltd. shall be the sole arbitrator who's decision shall be final and binding on both the parties.
- 5) All disputes shall be subject to Jurisdiction of Jammu City courts only.
- 6) Corrections or insertions in the tender form other than rates quoted shall be properly initialed. However, the rate should not have any correction.
- 7) Rates quoted shall be inclusive of all taxes, carriage from SAIL yard to fabrication yard and then to site of work and other incidental charges and nothing extra shall be paid other than the rates quoted by the firm and accepted by JKPCC Ltd.
- 8) In case the successful tenderer/ tenderers fails to fulfill the commitment in full or in the part, the JKPCC Ltd. will make alternative arrangement for the same at the risk & cost of successful tenderer and additional penalty upto 10% shall be imposed as per instructions of Managing Director, JKPCC Ltd.
- 9) The material i.e. nut bolts shall conform to IS 3640 grade 5.8 ( $\geq$  FY250) and u/bull dog clamps of ISI standard shall have to be supplied by the tenderer.
- 10) In case the material to be supplied by the firm is found to be sub-standard, it shall be the responsibility of the firm to remove the same from the site at his cost & risk and nothing shall be paid extra on this account.
- 11) **5% (Five percent)** of gross weight of structural steel consumed shall be allowed as scrap wastage (non-refundable) and cost thereof shall be deducted @50% of the stock issue rates. Any wastage beyond 5% shall be recovered @1.5 times of stock issue rates.

- 12) The tenderer shall have to provide necessary accommodation to the working staff at site at his own cost. The watch and ward of the bridge during execution shall be the sole responsibility of the tenderer.
- 13) Tender documents requested by mail will be dispatched by Registered Post/ Speed Post/ Courier Service on payment of an extra amount of Rs. 300/- (Rupees Three Hundred only). The JKPCC will not be responsible for the postal delay, if any, in the delivery of the documents or non-receipt of the same.
- 14) The rates should be quoted on the Annexure "A" enclosed both in figures and words and should be inclusive of all sorts of taxes as applicable.
- 15) In case of an unscheduled holiday on the prescribed tender sale closing date/ opening date of the tender, the next working day shall be treated as the scheduled prescribed day of the corresponding event.
- 16) Conditional tenders will be rejected without giving any reasons.
- 17) The tender shall be submitted under two cover system as described below:-

The first envelop clearly marked "ENVELOP No. 1" should only include the following:-

- i) Earnest money deposit as per Annexure in shape of CDR/ FDR pledged in favour of Financial Controller, JKPCC Ltd., Jammu.
- ii) Latest Sales Tax clearance certificate alongwith Sale Tax Registration No. & TIN No. and PAN No.
- iii) The tenderer must have satisfactorily completed similar nature of works in last three years for Rs. 60.00 Lacs (Rupees Sixty Lacs). The requisite certificate should be got from the officer not below the rank of Executive Engineer or equivalent.

The Second envelop clearly marked "ENVELOP No. 2" should only contain the rate quoted and nothing else. The rates quoted should be in the format specified with the tender documents.

Two sealed envelopes shall be enclosed in a bigger envelop addressed to the Managing Director, J&K Projects Construction Corporation Ltd., Haft Chinar, Near Sher Ghari Police Station, Srinagar which shall also be closed & sealed properly and subscribed tender for the items to be tendered alongwith NIT No, Date of receipt of opening with tenderers name shown on the bottom left hand corner.

- 18) After scrutiny of the qualification documents/ technical bid, the price offer of the qualified/ eligible tenderers shall be opened on the same date or any other subsequent date as convenient to tender receiving officer.
- 19) The tenders shall remain valid for a period of 90 days from the stipulated date of submission or as per discretion of accepting officer.
- 20) The tenderer should sign all the pages and tender documents before submission of the tender.
- 21) The quantities shown are approximate and may vary +/- 15%.
- 22) **Five percent** of each payment shall be retained as normal deposit and shall be released on completion of the work by the successful tenderer and income tax as applicable shall be deducted under rules.
- 23) **One percent cess** shall be deducted from running bills as per labour laws.

- 24) Scaffolding/ staging (complete in all respects) & equipments required during launching period shall have to be arranged by the tenderer himself. And nothing shall be paid extra on this account.
- 25) The tender issuing authority reserves the right to refuse to issue tender document to any supplier/ firm if not satisfied with their proof of eligibility without assigning any reason thereof.
- 26) The tender received after fixed date and time shall neither be opened nor considered at all. The date and time of receipt of such tenders would be marked on the envelope of tender receiving authority of this office representative. The disposal of the tender document will either be returned to the supplier/ firm casting the tender and earnest money released, but this will be done only after the concerned gives an undertaking for any of these two clauses clearly mentioning that he would have no claim what-so-ever over this contract. In case the tenderer does not come forward with the undertaking the envelope will remain in safe custody till its final disposal. However, this will not bar the department to process further in the matter to open other bids/ allot the contract and take up the supply.
- 27) Tenderers shall not be entitled to any claim what-so-ever on account of expenses incurred on submission of tender.
- 28) The Tenderers shall also be personally liable for the civil and criminal prosecution under the law if the specification of the fabricated material used is found in contravention to the specification prescribed during execution of the work even after the completion and finalization of contract i.e. at any time.
- 29) The tenderer will insure men and machinery against all sorts of risks in the job and will be solely responsible for any mishap. JKPCC in no case shall be responsible on this account.
- 30) The department is not responsible for electric supply. The firm at his own level shall arrange electric generator set/ electric connection from PDD for smooth running of work.
- 31) The allottee shall furnish the performance guarantee/ bank guarantee to the tune of **Rs. 20.00 Lacs** (Rupees Twenty Lacs only) as security deposit for successful and timely execution of work, which shall be pledged to Financial Controller, JKPCC Ltd.
